### I. Z-17-02:

RD America, LLC South Lee Street

Parcels: 7-259-005/220 Zoning from C-2 to M-1

Acres: 9.45

### P & Z Recommendation

#Z-17-02: RD America, LLC requested rezoning for the property located on South Lee Street, being parcels 7-259-005/220, containing 9.45 acres, from C-2 to M-1. Matt Reeves and Jerry Doss spoke on behalf of the applicant and explained the request to the Board. One person from the audience that is a customer spoke in favor of the request. There were no objections from the audience. Motion by Homer Whiting and seconded by Wayne Johnson to recommend approval of the rezoning to M-1 with the following conditions:

- 1. Architectural design and materials to be substantially similar to the rendering submitted with the application and subject to the approval of the Planning Director.
- 2. The applicant shall show compliance with Article 6, Section 6.1 of the City of Buford Development Regulations with concern to roadway frontage and access. Parcel 7-259-010 appears to be landlocked and the applicant shall provide sufficient detail for development regulation compliance. Review of this section and the proposed solution for compliance shall be reviewed and approved by the Planning Director prior to the approval of the land disturbance permit.

II. Z-17-03: Greg Sweatt 70 Church Street Zoning from C-2 to R-100

### P & Z Recommendation

#Z-17-03: Greg Sweatt requested rezoning for the property located at 70 Church Street from C-2 to R-100. The applicant was present and explained the request to the Board. There were no objections from the audience. Motion by Homer Whiting and seconded Harley Bennett to recommend approval of the rezoning to R-100 with the following conditions:

- The rezoning case supports the occupancy of the building with a residential use. Any
  future requests to change the occupancy of the building with a commercial or office
  use beyond that of a Customary Home Occupation, as defined in Article III of the City
  of Buford Zoning Ordinance, the applicant shall change the zoning category
  accordingly.
- Any business operating from the subject parcel after the rezoning to residential shall comply with City of Buford Zoning Ordinance Section 607, Customary Home Occupations.

RCCG – The House of Prayer 4907 Golden Parkway, Suite 100

## P & Z Recommendation

#SUP-17-08: RCCG – The House of Prayer requested a special use permit for the property located at 4907 Golden Parkway, Suite 100. The special use permit requested is to allow a church. Tolu Makinde spoke on behalf of the applicant and explained the request to the Board. Hours of operation and parking for the church were discussed. There were no objections from the audience. Motion by Wayne Johnson and seconded by Homer Whiting to recommend approval of the special use permit as requested with the following conditions:

- Prior to the issuance of any needed permits or certificate of occupancy, the applicant shall provide a parking analysis detailing the expected peak demands on parking to support the proposed church, the peak demands of the existing uses within the complex and demonstrate that demands do not exceed the available parking at the subject parcel.
- 2. Applicant shall submit a parking exhibit showing the available parking for the church.
- 3. Parking on the right-of-way and grassed areas are prohibited.
