- I. #SUP-22-17:

Mike Vahle (Public Storage) 4624 Friendship Road 08-156-002191

Request to allow a 3-story self-storage facility.

P&Z Recommendation

#SUP-22-17: Mike Vahle requested a special use permit for the property located at 4624 Friendship Road. The special use permit requested is to allow a three-story self-storage facility. The applicant was present and explained the request to the Board. He stated they are proposing one (1) climate-controlled storage building that will only have access from the inside the building. They are requesting a variance from the required number of parking spaces and to allow the use of the corporate color orange on the building. There were no objections from the audience. Motion by Harley Bennett and seconded by Amy Reed to recommend approval of the special use permit as requested with the following conditions:

1. No outdoor storage of junk vehicles is allowed on the site.

- 2. Landscape and architectural design shall follow Section 1316.1 Design Requirements, Buford Zoning Ordinance.
- 3. Parking design shall follow the standards outlined in Section 1316.1 Design Requirements, Buford Zoning Ordinance.
- 4. The final permitted plan shall be substantially similar to the site plan provided with this application.
- 5. The final plan needs to be approved by the Planning Director.
- 6. To allow the corporate color orange on the building as per the building elevation provided with this application.

II. #SUP-22-18:

Buford Lanier Storage, LLC 6702 McEver Road 08-160-001005

Request to allow a self-storage facility with boat and RV parking/storage with a buffer reduction.

P&Z Recommendation

#SUP-22-18: Buford Lanier Storage, LLC requested a special use permit for the property located at 6702 McEver Road. The special use permit requested is to allow self-storage facility with boat and RV parking and storage. Mitch Peevy spoke on behalf of the applicant and explained the request to the Board. He stated this development would be a mixture of self-storage and boat and RV storage. He stated they are asking for a buffer reduction adjacent to residential zoned property to 0 feet. There were no objections from the audience. Motion by Amy Reed and seconded by Jeff Pirkle to recommend approval of the special use permit with the following conditions:

- 1. Approval of this special use permit is for Buford Lanier Storage, LLC and will expire should the applicant vacate the site.
- 2. A 15-foot replanted buffer with evergreen trees and shrubs shall be provided adjacent to the east side of the property where it abuts the residential site. The final plan needs to be approved by the Planning Director.

- 3. The road frontage shall have a 10-foot landscape strip with a variety of evergreen trees and shrubs. The final plan is to be approved by the Planning Director.
- 4. Entrance limited to one driveway to be approved by the Georgia Department of Transportation.
- 5. No accumulation of junk boats and no mechanical work on boats and RVs are allowed.
- 6. All parking and driveway surfaces to be asphalt or concrete with curb and gutter meeting the minimal standards of the City of Buford Development Regulations.
- 7. The fence and gate along the frontage of McEver Road shall be a black metal decorative fence with brick columns. The remaining fence along the sides and rear shall be a black coated chain link fence.
- 8. The building elevations shall be constructed of brick, stucco, or stone on all four sides.
- 9. All drive isles shall be no less than 24 feet in width.
- 10. The final permitting plan shall be substantially similar to the site plan provided with this application.

III. #SUP-22-21:

Powerstroke Specialty, LLC 1046 Parkway Court, Suites A, B, C, D & E 7-299-001043

Request to allow Ford diesel pick up truck repair and restoration.

P&Z Recommendation

#SUP-22-21: Powerstroke Specialty, LLC requested a special use permit for the property located at 1046 Parkway Court, Suites A, B, C, D, and E. The special use permit requested is to allow Ford diesel pickup truck repair and restoration. The business owners were present and explained the request to the Board. The Board stated that there were a lot of vehicles and parts on the property. They stated they have started cleaning up the site and have secured three (3) acres out of the City to store the vehicles that are waiting for service. There were no objections from the audience. Motion by Jeff Pirkle and seconded by Amy Reed to recommend approval of the special use permit with the following conditions:

- 1. Business operations shall not include outdoor storage of business products for repair. The site shall be maintained in an orderly manner.
- 2. All vehicles shall park within hard surface designated striped parking spaces only.
- 3. Approval of this special use permit is for the current applicant and will expire should the applicant vacate the site.
- 4. Up to 25 vehicles shall be stored on the site in an orderly manner waiting for repairs.
