August 1, 2022

The regular monthly meeting was held on August 1, 2022 at Buford City Arena and all Commission members were present.

Chairman Beard called the meeting to order at 7:00 p.m. and Mr. Branch led the Pledge of Allegiance.

Chairman Beard stated at this time there would be a public hearing on the Fiscal Year 2023 Operating Budget and 2022 millage rate rollback for Gwinnett and Hall County property taxes. Chairman Beard opened the hearings with comments on the FY 2023 budget, the proposed tax increases for 2022 and gave an overview of the law and the City's proposed millage rate. The Commission is proposing a millage rate of 12.55 for 2022 for both Gwinnett and Hall Counties, Hall County with the LOST rollback. The property tax increase for Gwinnett County is proposed at 18% over the rollback millage rate of 10.636 and the property tax increase for Hall County is proposed at 7.23% over the rollback millage rate of 11.704. The public was given an opportunity to provide comments on the budget and millage rate rollback. The audience did not have any comments or questions regarding the proposed Fiscal Year 2023 Operating Budget, the 2022 proposed Gwinnett and Hall County millage rate or the proposed 2022 millage rate for Hall County with the LOST rollback.

Chairman Beard stated that this concludes the public hearing portion of the meeting.

Motion by Mr. Burge, seconded by Mr. Weeks to approve the 2022 property tax millage rate for Buford City Schools in Gwinnett County of 12.55 mills and 13.027 mills in Hall County. Hall County Local Option Sales Tax rollback is 0.477 mills with a net millage rate for property taxes in both Gwinnett County and Hall County of 12.55 mills. Property 13 taxes bills are due December 20, 2022.
